Current Situation	 smoke coming from trees and stumps for days following their return. Proceed with caution because burned out areas may have unseen hazards. Residents are encouraged to call 911 if they are concerned about any active flames near their homes or businesses. Dixie Fire East Zone: Low relative humidity and Red Flag warnings will resume this morning and is forecasted to continue through this evening. In the Mount Ingalls, Red Clover Creek areas, strong southwest winds will continue to increase fire activity as it did yesterday. Smoke plumes should again be visible for miles. Fire Crews shored up the dozer lines along Grizzly ridge as they firmly hold the line on the western side. Contingency dozer lines are being constructed in the Squaw Queen Creek area to help drive the fire from the North Lake Davis area up into the Walker scar, where fuel loads are lighter. Mop up continues around the homes in Genesee Valley and into Taylorsville with tactical patrols, responding to any smoke reports, and actively looking for any hot spots. New contingency lines are being added between the fire, Greenhorn, Portola, and the communities further south all the way around North Lake Davis to protect the homes. National Forest Closures	The Pacific Southwest Region is temporarily closing all R5 National Forests to provide better public and firefighter safety due to extreme fire conditions throughout the state and strained firefighting resources throughout the country. This closure will be effective on Tuesday, August 31, 2021, at 11:59 p.m. through September 17, 2021, at 11:59 p.m. This Order does not affect the Humboldt-Toiyabe National Forest, which is not in the Pacific Southwest Region. (See Regional Order No. 21-07: Emergency Forest Closure link: https://www.fs.usda.gov/Internet/FSE_DOCUMENTS/fseprd949149.pdf). The Lassen National Forest's Order No. 06-21-08: Expanded Dixie Fire Closure Order prohibits the public from entering within the Dixie Fire Closure Area or any National Forest System Roads or trails described in Exhibits A & B. Bureau of Land Management	The Bizz Johnson National Recreation Trail near Susanville, as the Bureau of Land Management has rescinded a temporary emergency closure associated with the Dixie Fire. Also reopened are the Hobo Camp and Devil's Corral trailheads and all other BLM-managed lands that were affected by the emergency closure that went into effect Aug. 16. This includes BLM-managed lands south of California Highway 36, west of U. S. 395. and north and east of the Lassen National Forest boundary.
Lassen Evacuee Campsites	The Lassen National Forest has the Christine Campground on Eagle Lake Ranger District and the Bridge Campground on the Hat Creek Ranger District available for evacuees. Evacuee's primary residence must be under mandatory evacuation and need to check in with the campsite's hosts. Before you go, make sure the campgrounds are not under any evacuation warnings.
