	CURRENT SITUATION
Situation Summary: Incident Information:	The fire remained very active overnight due to the extremely poor humidity recovery and warm temperatures. Spotting continued to occur with spots being found up to .5 miles away from the edge of the fire. The fire continued to back down towards Highway 50 in Division F & G with slow rates of spread. Today firefighters will face more dry conditions and strong winds with gusts up to 35-40 mph in some areas. The current red flag warning remains in effect through 11:00 p.m. on 9/1/21.
