CURRENT SITUATION

WEST ZONE Situation Summary:

Incident Information:



Fire behavior continued to decrease last night thanks to a slight rise in humidity levels and decrease in temperatures across the entire area. The only areas of minimal growth were in the northeast and southern edge, as crews were able to go direct when safe. Hot material continues to be found along the perimeter of the fire, as well as an abundant amount of fire weakened timber. Firefighters will work today mopping up and mitigating any threats to existing lines. Smoke may be visible throughout today as interior islands continued to smolder and burn out. Damage inspections are still underway with approximately 75% of structures assessed.

To better provide public and firefighter safety due to extreme fire conditions throughout Northern California, and strained firefighter resources throughout the Country, the USDA Forest Service Pacific Southwest Region is announcing a temporary closure of all National Forests in California. EAST ZONE Situation Summary:	Firefighters are taking advantage of the favorable weather conditions by continuing their aggressive mop up operations and direct firefighting tactics. Despite some continued spotting behavior in the northeastern head of the fire, crews were successful in holding the fire within its current footprint. The fire is most active on the south side of Echo Lake, where it is backing down to the lake edge. Safety concerns for firefighters are potential rollout of smoldering material in the steeper hillsides along the northeastern edge, and hazardous burning snags on the north side of Caples Lake and Highway 88. Firefighters are also taking advantage of topographical features to help prevent progression of the fire in this area, while dozer operators continue their line construction to the east of Caples Lake.					
	Structure protection groups continue to work in the communities under evacuation near the fire's edge, seeking out hot spots and mopping up around structures, especially within the communities on the north flank and Pioneer Trail.
